Eagle Ranch is one of Georgia's largest residential programs for children in crisis, serving North Georgia and Metro Atlanta since 1985. Families turn to Eagle Ranch when life becomes a daily struggle with their child. We address behavioral, academic, emotional and social challenges that families have difficulty resolving on their own.

This resource is meant to help you incorporate serving into your schedule and into your life. As you look over this list of opportunities to serve the children and mission of Eagle Ranch, determine which need best uses your gifts, passions, and skills.

Eagle Ranch has ongoing volunteer opportunities for church members. Sunday School classes and other church groups may participate in Saturday work parties, prepare a meal for a home or host a lunch for students on activity days. Individuals may volunteer to teach exploratory classes in our school or officiate in our winter basketball league.
